DEED OF VARIATION TO THE SUPPLEMENTAL FUNDING AGREEMENT

THIS DEED is made the 24 day of JANVARY 202/2

BETWEEN

1) The Secretary of State for Education (the "Secretary of State"); and

2) Learn@ MAT, (the "Company") a charitable company incorporated in England and Wales with registered number 10377760, together, the "Parties".

INTRODUCTION

- A. The Parties entered into a supplemental funding agreement dated 24 August 2017 as amended by Deeds of Variation dated 10 October 2019 and 29 June 2021 (the "Supplemental Funding Agreement") relating to the establishment, maintenance and funding of Knowle DGE Academy in accordance with the Supplemental Funding Agreement.
- B. The Parties now wish to vary and amend certain terms and conditions of the Supplemental Funding Agreement in accordance with the terms of this Deed.
- C. This Deed is supplemental to the Supplemental Funding Agreement.

1. INTERPRETATION

1. 1 Words, expressions and interpretations used in this Deed shall, unless the context expressly requires otherwise, have the meaning given to them in, and shall be interpreted in accordance with, the Supplemental Funding Agreement.

2. VARIATION OF THE SUPPLEMENTAL FUNDING AGREEMENT

- 2.1 The Parties agree that with effect from 1 September 2021, the Supplemental Funding Agreement shall be amended as follows:
 - 2.1.1 that the summary table on page 4 be amended as follows:
 - a) the planned number of places of "156" shall be replaced with "176".
 - b) b) the residential places shall be stated as being "18".
 - 2.1.2 that clause 2.C be replaced with a new clause 2.C in the following form:
 - "2.C The planned number of places at the Academy is 176 places in the age range 5 to 19, including 18 residential places and a sixth form of 40".
- 2.2 Except as varied by this Deed, the Supplemental Funding Agreement shall remain in full force and effect.

3. GOVERNING LAW AND JURISDICTION

- 3.1 This Deed, and any disputes or claims arising out of or in connection with it, its subject matter or formation (including non-contractual disputes or claims), shall be governed by and construed in accordance with English law.
- 3.2 The Parties irrevocably agree that the English courts have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this Deed or its subject matter or formation (including non-contractual disputes or claims).

4. COUNTERPARTS

4.1 This Deed may be executed in any number of counterparts and by the Parties to it on separate counterparts, each of which when so executed and delivered shall be an original, but all the counterparts shall together constitute one and the same instrument.
